They spoked with them about coming into compliance with staff/board training and updating policies. They plan on meeting with them again in March to follow up on their progress. The Humane Society has established a good working relationship with Colony Caregivers leadership. They have invited County officials to the next meeting that they have with them. Mr. Young would like to do a presentation on the Agricultural and Markets Law and what is required by the county for the Board. That presentation would be followed by a presentation from the Humane Society on the services they have available. They have also agreed to give privilege of the floor to the public at a later date.
