Local Law No. FOUR of the year 19 85.....

A local law to Provide for Salary Changes for Various County Officers - Elected or Appointed for the Year 1985.....

Be it enacted by the Board of Supervisors of the
(Name of Legislative Body)

County of Ontario, New York as follows:

SECTION 1. Commencing July 1, 1985, the salary of the incumbents in the following county positions shall be the amount set forth opposite each such position for the time period shown, to wit:

Division Manager - Human Services	7/1/85-12/31/85	\$2,125
Division Manager - Governmental Operations	7/1/85-12/31/85	\$2,500
Division Manager - Financial Management	7/1/85-12/31/85	\$1,000
Division Manager - Planning and Development	7/1/85-12/31/85	\$2,375
Division Manager - Health and Medical Services	7/1/85-12/31/85	\$2,000

Ontario County Administrator (Annual Salary) \$43,500

SECTION 2. An incumbent holding a position described in this local law at any time during the period from July 1, 1985, until the time when basic annual salaries are first paid pursuant to this local law for such services in excess of the compensation actually received therefor, shall be entitled to a lump sum payment for the difference between the salary to which such incumbent was entitled for such service and the compensation actually received therefor. Such lump sum payment shall be made as soon as practicable.

SECTION 3. All local laws and resolutions of the Board of Supervisors of Ontario County, to the extent that the same are inconsistent with this local law, are hereby superseded by this local law.

SECTION 4. This local law is adopted subject to a permissive referendum, and the Clerk is directed to publish notice of the same as required by law.

SECTION 5. This local law shall become effective in accordance with the provisions of the Municipal Home Rule Law of the State of New York.

I hereby certify that the local law annexed hereto, designated as local law No. of 19 of the City of having been submitted to referendum pursuant to the provisions of § 36 of the Municipal Home Rule Law and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the special election held on 19 became operative.

I hereby certify that the local law annexed hereto, designated as Local Law No. of 197 of the County of, State of New York, having been submitted to the Electors at the General Election of November, 19, pursuant to subdivisions 5 and 7 of Section 33 of the Municipal Home Rule Law and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.
