SECTION 1: ARTICLE VI, Sewer Rent Rate, of Local Law No. Two of 1983, entitled "Ontario County Sewer Rents Local Law, Canandaigua Lake County Sewer District, Honeoye Lake County Sewer District, and Extension No. 1 of the Honeoye Lake County Sewer District" is hereby amended to read as follows:

ARTICLE VI

SEWER RENT RATE

Section 6.0: Sewer rents are hereby established as follows:

- Section 6.01: For premises within the Canandaigua Lake County Sewer District; benefit zone No. 2 - \$139.00 per equivalent single house unit per year.
- Section 6.02: For premises within the Canandaigua Lake County Sewer District; benefit zone No. 1 - \$291.00 per equivalent single house unit per year.
- Section 6.03: For premises within the Honeoye Lake County Sewer District; benefit zone No. 1 - \$266.00 per equivalent single house unit per year.
- Section 6.04: For premises within extension No. 1 of the Honeoye Lake County Sewer District; benefit zone No. 2 - \$266.00 per equivalent single house unit per year.

SECTION 2: ARTICLE VII, "Effective Date", is hereby amended to read as follows:

ARTICLE VII

EFFECTIVE DATE

Section 7.0: The rates established by this Local Law shall take effect on January 1, 1987, with the first payment under the amended rates being due and payable on April 1, 1987.


