Local Law No. Seven of the year 19 91
A local law Imposing a surcharge on Telephone Access Lines to Provide Revenue for System Costs Associated with the Development and Operation of an Enhanced 911 Emergency Telephone System in the County of Ontario

Section 1.

Pursuant to Section 303 of the County Law of the State of New York, there is hereby imposed a surcharge of thirty-five cents (\$.35) per month on each local telephone exchange access line in the County of Ontario, subject to the restrictions set forth herein.

Section 2.

The surcharge provided for herein shall not apply to more than seventy-five (75) local exchange access lines per customer, per location.

Section 3.

The surcharge provided for herein shall not apply to any "Lifeline" customers of local telephone service suppliers.

Section 4.

The surcharge provided for herein shall not apply to the access lines of the County of Ontario.

Section 5.

The estimated target date for the commencement of enhanced 911 emergency telephone service in the County of Ontario is June 1, 1994.

Section 6.

All suppliers of local telephone exchange access lines within the County of Ontario shall begin to add the thirty-five cent (\$.35) per month surcharge as provided for herein to all service bills issued after September 1, 1991, subject to the exclusions set forth herein.

This local law shall become effective immediately upon filing in accordance with the provisions of Sections 20, 21 and 27 of the Municipal Home Rule Law of the State of New York.
