Local Law No. Eleven of the year 19 91

ARTICLE I.

SHORT TITLE AND APPLICABILITY

Section 1.0: Short Title

This Local Law shall be known as the Ontario County Sewer Rents Local Law, Canandaigua Lake County Sewer District and Extensions Thereof, and Honeoye Lake County Consolidated Sewer District and Future Extensions Thereof.

Section 1.1: Applicability

This Local Law shall apply throughout the Canandaigua Lake County Sewer District, benefit zones numbers 1 and 2 and all extensions thereof; the Honeoye Lake County Consolidated Sewer District, and all future extensions thereof; except that this Local Law shall not apply to the Route 332 Extension of the Canandaigua Lake County Sewer District to the extent sewer charges are otherwise provided for.

ARTICLE VI

SEWER RENT RATE

Section 6.0:

Sewer rents are hereby established as follows:

Section 6.1:

- A. For calendar year 1992 for premises within the Canandaigua Lake County Sewer District, Benefit Zone No. 2 - \$267 per equivalent single house unit per year.
- B. Effective January 1, 1993, and thereafter for premises within the Canandaigua Lake County Sewer District, Benefit Zone No. 2 - \$307 per equivalent single house unit per year.

Section 6.2:

- A. For calendar year 1992 for premises within the Canandaigua Lake County Sewer District Benefit Zone No. 1 and all extensions of the district - \$307 per equivalent single house unit per year.
- B. Effective January 1, 1993, and thereafter for premises within the Canandaigua Lake County Sewer District Benefit Zone No. 1 and all extensions of the district - \$349 per equivalent single house unit per year.

Section 6.3:

Premises within the Route 332 Extension of the Canandaigua Lake County Sewer District shall be excluded from this Sewer Rents Local Law to the extent otherwise provided for.

Section 6.4:

- A. For calendar year 1992 for premises within the Honeoye Lake County Consolidated Sewer District and extensions thereof - \$286 per equivalent single house unit per year.
- B. Effective January 1, 1993, and thereafter for premises within the Honeoye Lake County Consolidated Sewer District and extensions thereof - \$373 per equivalent single house unit per year.

ARTICLE VII.

EFFECTIVE DATE

Section 7.0:

This Local Law shall take effect January 1, 1992.
