Section 1: Legislative Intent

The Board of Supervisors hereby finds that it is in the public interest that the position of Finance Officer and Auditor in the service of Ontario County be exempt from the requirement of Public Officers Law § 3(1) that specifies residency within Ontario County. It is the intent of this local law to supersede that provision insofar as it applies to the aforesaid position.

Section 2: Finance Officer and Auditor

The provisions of Public Officers Law § 3(1) requiring public officers employed by Ontario County to be residents of Ontario County shall not prevent a person from holding the position of Finance Officer and Auditor, provided that such person resides in the State of New York.

Section 3: Effective Date

This local law shall take effect immediately.
