Be it enacted by the Board of Supervisors by the County of Ontario, New York, as follows:

**SECTION 1. LEGISLATIVE INTENT.**

The Board of Supervisors of the County of Ontario heretofore adopted Local Law No. 5-1996 entitled "A Local Law Applying the Management Compensation Program to Certain County Officers Appointed for Definite Terms for the Year 1997". Additionally, this Board of Supervisors heretofore adopted Local Law No. 3-1997 entitled "A Local Law Creating the Position of Deputy County Administrator, Abolishing Several Operating Divisions, and Further Clarifying Various Management Responsibilities". These local laws modified the salary of the Director of Human Resources, and this local law is intended to readjust that salary during his term of office.

**SECTION 2.**

Commencing upon the adoption of this local law and retroactive thereto, the salary for the incumbent Director of Human Resources shall be \$67,685.00 at Step 5 with a MCP factor of 100.

**SECTION 3.**

All local laws and resolutions of the Board of Supervisors of Ontario County to the extent that the same are inconsistent with this local law are hereby superseded by this local law.

**SECTION 4.**

This local law is adopted subject to a permissive referendum and the Clerk is directed to publish notice of the same as required by law.

This Local Law shall become effective on the date when it is filed in the Office of the Secretary of State of the State of New York and in accordance with the principles of the Municipal Home Rule Law of the State of New York.
