SECTION 1: Purpose: The Board of Supervisors intends by this local law to prescribe by law, as required by Real Property Tax Law Section 922(1)(a)(xiii), for the identification and separate listing on County tax bills of the costs incurred by Ontario County relating to the State-Mandated Medicaid Program.

SECTION 2: Itemization of Medicaid Required: All statements of taxes owed to the County of Ontario shall hereafter contain an itemization of taxes owed relating to state-mandated Medicaid costs, to be stated separately and distinctly from all other taxes owed to Ontario County.

SECTION 3: Effective Date: This local law shall take effect immediately.
