A local law TO ITEMIZE COSTS CONTAINED IN THE COUNTY'S TAX BILL

Section 1: Purpose: The Board of Supervisors intends by this local law to prescribe by law as required by Real Property Tax Law Section 922(1)(a)(xiii), for the identification and separate listing on the County tax bills of the costs incurred by Ontario County relating to services provided to the participating cities and towns, including Worker's Compensation insurance premiums, town cost of production of real property assessment and tax documents, and the recapture of erroneous or refunded town taxes.

Section 2: Itemization of Municipal Services Required: All statements of taxes owed to the County of Ontario shall hereafter contain an itemization of taxes owed relating to the combined amount of Worker's Compensation insurance premiums, town cost of production of real property assessment and tax documents, and the recapture of erroneous or refunded town taxes, to be stated separately and distinctly from all other taxes owed to Ontario County.

Section 3: Effective Date: This local law shall take effect immediately.
