WHEREAS, Resolutions Nos. 294-2017, 614-2017, and 485-2018 authorized a contract and contract amendments, respectively, with The Pike Company, One Circle Street, Rochester, NY 14607 for professional construction management services related to said Project, contemplating a 12 month duration of construction for the renovations of 74 Ontario Street; and

WHEREAS, During the course of design of said renovations of 74 Ontario Street and analysis of construction scheduling, The Pike Company has determined that a fifteen (15) month duration of construction is necessary, and

WHEREAS, Resolution No. 695-2018 adopted the County’s 2019-2024 Capital Improvement Plan; and

WHEREAS, Said plan included funding in 2019 for the reconstruction and expansion of the Ontario County Sheriff’s Firing Range; and

WHEREAS, The Pike Company has submitted a proposal dated January 24, 2019, a copy of which is on file with the Clerk of this Board as Schedule “A” of the proposed contract amendment, wherein The Pike Company proposes to: 1.
