A 590 sq. ft. existing one story entry vestibule will be removed. 4. A 398 sq. ft. one story addition to create a new entry lobby. 5. Site work including new security gates, creation of 6 handicap accessible, 2 public, and 16 secure parking spaces, and replacement of any aged utility infrastructure (sewer, electric, water, gas, telecommunications). 6. Issuance of Serial Bonds of up to \$5 million to fund the project. 7. Consideration of exemption from zoning under the balancing of interests test.

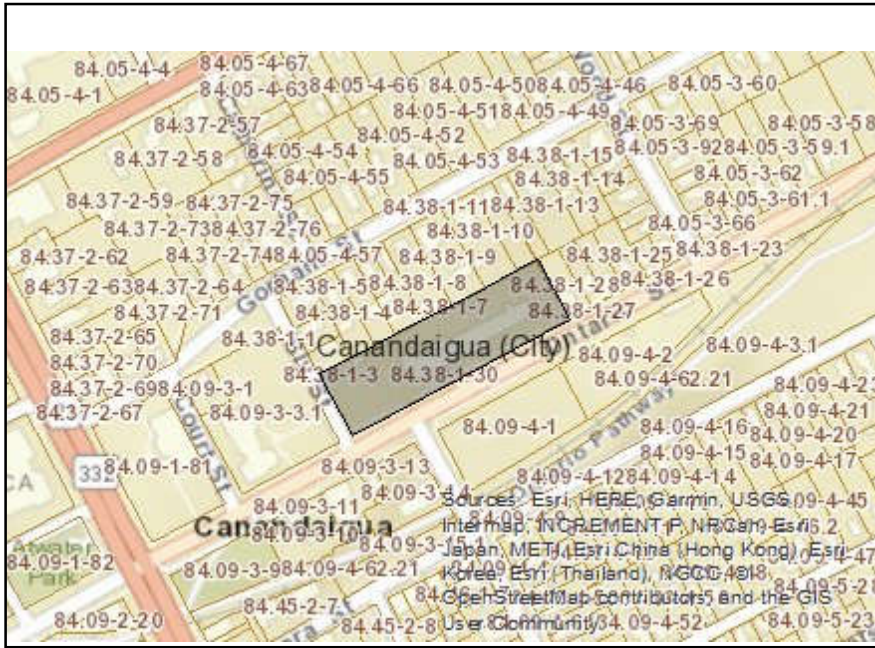
